As a rider, Rob was the AGA Rider of the Year in back to back years, four-time West Coast Rider of the Year, and a three-time World Cup team member. He has traveled far and wide teaching clinics throughout the continental U.S., New Zealand, South Korea, Alaska, Hawaii, Costa Rica, Venezuela and Mexico. Rob is an "R" rated USEF judge, course designer, and a co-creator, vice-president and judge on "Judge My Ride". Rob will be giving private and group clinics at various barns around the island.
