ENTRY AGREEMENT

All classes will be judged according to the specifications outlined in the HHSA prize list class descriptions and in accordance with United States Hunter Jumper Association (USHJA) Rules.

Competitors, trainers, horses, and horse owners must be current members of the HHSA in order to qualify for show championship and year-end awards, with the exception of those riders entered in the Short Stirrup/Long Stirrup Division. Riders wishing to accrue USHJA Outreach points must be members of USHJA for their points to accrue.

I have read the HHSA and USHJA rules and the specifications as printed in the Prize List for this Competition and agree to all of its provisions. I understand and agree that by entering this Competition, I am subject to the current HHSA Rulebook and the stated rules of the competition. By entering this competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaultor or Longueur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of the HHSA, USHJA, and the rules of the Competition. I agree to be bound by the Bylaws and Rules of the USHJA, HHSA, and of this competition. I will accept as final any decision of the Judge, the Show Steward, an adjudicator, an HHSA Board Representative, and/or Hearing Committee on any question arising under any of these Rules, and agree to release and hold harmless the competition, the HHSA, the USHJA their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered.

Show management reserves the right to limit or revoke participation at any time to anyone. Riders and/or horses deemed unsafe by Show Management, Steward, or Judge will be asked to dismount and leave the ring immediately.

HHSA is a USHJA Affiliate Organization. The 2021 Fall Frolic Horse Show is a USHJA Outreach Competition Offering USHJA Outreach Classes, which qualifies riders, who are members of USHJA, for Outreach year-end awards for Zone 11 (Hawaii). These points are accrued by the rider.

The USHJA Outreach Program is open to both Juniors (17 and under) and Adult Amateurs who possess current USEF Amateur certification.

Riders need not be members of USHJA (United States Hunter Jumper Association) to compete in this horse show, but if they are, their points in Outreach classes will accrue, and they will qualify for Zone 11 year-end awards. USHJA Outreach Membership is free. All Outreach class participants must join as an USHJA Outreach Member to be eligible for zone awards. USHJA members will receive *In Stride* magazine plus all the rights and privileges of USHJA membership for that year. USEF and USHJA hold and provide no regulatory function regarding the competition or association. Because these competitions are not sanctioned or licensed, neither USEF nor USHJA will hear grievances or become involved in the regulatory process of the competition, association or their participants. Compliance with USHJA Outreach Competition requirements is the responsibility of the individual competition management at each event.

New Format for Upcoming Fall Frolic Show

Due to the recent increase in COVID numbers, we don't have a facility able to host our Fall Frolic Show on September 25 and 26. While this is unfortunate news, the HHSA board has been working to make this show a reality. We have come up with an innovative way to stay the course and have our 3rd show. It is an “open score card” concept.

The show will still happen the weekend of Sept 25/26 with riders competing at their individual barns. The barns have pre-approved this concept and will make the necessary course preparations for their riders. The judge will travel to each barn (with the show secretary and a HHSA Board member) and have an open scorecard. Once all riders have competed in a class, the judge will provide final results for the class.

We did need to make some changes to the course offerings. The derbies will not be held and neither will the western classes. To allow ample time for logistical planning for judges schedule, please get your registration in as soon as possible.

There will be no late entries and the entry deadline closes on September 18.

FAQs

1. **Will FLAT Classes still be held? And how will this be judged fairly?**

Yes, flat classes will be held. This is an open card format. The contracted Judge is a professional and will judge each rider accordingly.

2. **Will short/long stirrups be held?**

Yes, all short/long stirrup classes will be held. Further, there is also a virtual offering for these classes as well.

3. **Will the same divisions be held on the same day as usual?**

No, the judges will run through all classes on the same day, based on what each rider at each barn is riding. The judge will not be visiting each barn on both days. He will be going to each barn once over the course of the weekend. This is the only reasonable and realistic way to split the time and get it all done.

4. **Since there are less riders, how are we preventing horses and riders from being exhausted from going in back to back classes (without the usual waiting around time to learn new courses etc)?**

We have a few riders that ride in open and juniors in a few height divisions. Riders and trainers will need to be cognizant and sensitive of horse exhaustion and choose classes accordingly. We realize this means a rider/horse combo may not be able/willing to enter as many classes given classes are not spread out over two days.

5. **Since it's a modified show, is there a modified cost to each class due to each barn doing all the course/show setup?**

No, the class cost does not change. HHSA still has many large expenses associated with the show such as paying for judges airfare, lodging, rental car, etc. HHSA also needs to secure the necessary insurance for the event. The expense load remains high.

6. **Is there a plan to video each course to handle any questions/disputes?**

There is no plan to video all classes at the time. This is, however, a good idea. Perhaps the barn leaders can assign someone the video the rounds. If the judge has questions, he can go back for reference.

7. **Is there an option to postpone and us all come together in NOV and have a normal end of the year show?**

We did look into this option and HHSA can't postpone the judge, Otis Brown (together with unknowns about the COVID environment), therefore the show will be proceeding, in a revised format, Sept 25/26.

The one advantage of an open card concept, is all riders will have their home-court advantage. Please remember to register by September 18.

General Rules and Information

No other persons besides show management or their representative may approach the Judge during the show. Questions or concerns should be directed to the Show Steward/Adjudicator. Approaching the Judge prior to the completion of the last class may result in disqualification from the show and/or a possible fine to be determined by the HHSA Awards Committee.

Dogs: Dogs are not permitted on the show grounds.

Eligibility: Ribbons won in Hunter Seat Classes (not to jump) shall not affect a rider's status in classes over fences. Eligibility to enter Short Stirrups/Long Stirrups classes should be checked with the HHSA Records Keeper and/or show secretary.

Entry Fees: Entry fees for all classes are listed on the show entry form. Your credit card will be charged for all registered classes upon the close entry deadline. **Any additions made to an entry on the day of the show will incur a \$10 late fee/per class.**

Post Entries: Must be made prior to the first call of the previous class. Exhibitors submitting an entry blank after the closing date may post-enter at the regular fee plus \$10 per class. In classes requiring individual work, post entries may be placed first in the starting order. A competitor must have a completed entry and signed waiver to compete. A horse must have a completed entry and waiver signed by the owner or lessee to compete.

In all Performance Classes (open, children's, adult amateur) the points follow the horse and in equitation and medal classes the points follow the rider. Entries not received by the closing date will be subject to the \$10 post entry fee per class.

Scratches: After the close of the entry date, no refunds will be made unless scratches are due to horse unsoundness or personal illness (see refund section for details).

Refunds: After the close of the entry date, refunds (less \$10 for handling expenses) will be returned only upon written certification of unsoundness by a veterinarian (or Judge during the show), or in the case of personal illness, by a physician. Certifications must be received within three (3) days after the close of the show.

Hat Rule: It is compulsory for all persons at HHSA hunter, jumper or hunter/jumper competitions, when mounted anywhere on the competition grounds, to wear properly fastened protective headgear, which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. It must be properly fitted with the harness secured. It is required when riding on the flat and jumping anywhere on the competition grounds. The Judge must bar riders without protective headgear from entering the ring for classes in which protective headgear is required and may bar any entry or person from entering the ring if not suitably presented to appear before an audience.

HHSA Membership: Competitors, trainers, horses, and horse owners or lessees must be current members of the HHSA in order to qualify for show championships and year-end awards. Current membership numbers must be included on entry blanks. Parents or guardians signing as trainer or coach do not have to be current members. Exception: Competitors and horses in the Short Stirrup/Long Stirrup Division are not required to be members of HHSA.

USHJA Membership: This is a USHJA Outreach competition offering selected Hunter and Equitation classes for all riders including Juniors and Adult Amateurs. For Zone award points in these classes to be accrued, the rider must be a member of USHJA. These points are accrued by the rider. USHJA Outreach Membership is free. All Outreach class participants must join as an USHJA Outreach Member to be eligible for zone awards.

Volunteer Requirement for year-end Awards: HHSA is an all-volunteer organization. We need parents and riders to actively help us organize and run these horse shows. In addition, to qualify for 2021 year-end awards, each HHSA competing member must contribute at least six (6) hours of volunteer work at HHSA-sanctioned events during the 2021 show season. A rider under 14 years of age may have a parent or other sponsor volunteer for a minimum of six (6) hours on his or her behalf. For a horse to be eligible for year-end awards, the rider or owner must volunteer at least six (6) hours. Please contact the **volunteer coordinator** for volunteer opportunities associated with this show.

Kickers: Horses that kick must be marked with a red ribbon on the tail.

Numbers: There is a \$5 fee for numbers not returned by the end of the show.

Prize Money: Checks or Paypal/Venmo will be mailed/sent within 14 days after the close of the show. Checks/Paypal/Venmo will be payable to the owner listed on the entry blank.

Show Hours: The first warm-up class will begin promptly at **UPON ARRIVAL OF THE JUDGE TO THE FACILITY**. In the case of public address system malfunction, it is the rider's responsibility to be on time for each class.

Tack: Correct tack must be used in all events. Regulations are stated in both the HHSA and USHJA rule books. It is the exhibitor's responsibility to be familiar with and comply with HHSA and USHJA rules.

Ties: In the case of ties for Championships, the winner will be the horse that has accumulated the most points over fences. Should a tie still exist, dual Championships will be awarded and no reserve championship will be given. If a tie exists for reserve championship the winner will be the horse that has accumulated the most points over fences, should a tie still exist, dual reserve championships will be awarded.

Warm-Up Classes WU-1, WU-2, WU-3, WU-4, WU-5, WU-6 WU-7: Non-judged warm-up rounds will be available for a \$25 fee per round in the main arena. These warm ups are open to all horses and riders provided they have a completed entry form and signed waiver for the competition. Horses or riders do not have to be entered in any specific height division to enter to ride in any warm up. Any horse or rider entered in the horse show may ride in any warm up. There will be seven (7) specific warm-up sessions based on fence height. Fences will be available at the minimum height in each warm-up. The designated warm-up round that all warm-up competitors will ride, will be the posted Course A or Course B. Riders and horses may enter the warm-up with the same rider or different riders. A rider that is entered in multiple warm-up rounds may select to remain in the arena to complete the additional warm up round. NOTE: There is a limit of two (2) rounds per horse per warm-up division. See class list for schedule of warm-up classes.

Warm Up For Short Stirrups /Long Stirrups – NO FEE: There will be no individual warm-up rounds for Short Stirrups/Long Stirrups. Instead, after the course is set for the 18" cross rail and ground poles classes, the arena will be open for at least a 15-minute period where riders entered in the horse show and Short Stirrups/Long Stirrups Competitors may school with their trainers and warm up over the course or on the flat. There will be no charge for this warm up opportunity.

Schooling Fences: Fences will be set up in the warm-up arena. Specific schooling regulations will be posted at the secretary's booth and must be observed by exhibitors. NOTE: Exhibitors must wear hard hats while schooling or riding on the grounds.

Jumping Order: This will be assigned according to the receipt of entries by the Show Secretary. Entries received last will be placed first in the jumping order, starting with post-entries. If entries warrant classes jumping the same height will be run together. Prizes will be awarded separately according to the class entered.

Location of show: VARIOUS FACILITIES

Motorized Vehicles: Minors who do not have a valid driver's license, which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles on the competition grounds of recognized competitions. Minors who have a valid temporary license may operate the above described motorized vehicles, provided they are accompanied by an adult with a valid driver's license. The parent(s), legal guardian(s), or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for sanctions by HHSA against the parent(s), guardian(s), and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

ATTENTION: To qualify for HHSA show championships and year-end awards, rider, horse, and owner or lessee must be current members of HHSA (except for Long/Short Stirrups). Proof of membership may be required. It is suggested that you attach a copy of all current HHSA membership email verifications or cards for rider, horse, and owner, with your show entry forms. 8

NOTE: Adult Amateurs will need to attach a copy of their USEF Amateur Certification to participate in Adult Amateur classes and to qualify for show and year end championships point accrual. Please email show secretary a copy of your USEF Amateur Certificate

NOTE: Outreach competitors who wish their points to be accrued for Outreach Classes must also be members of USHJA. In order to participate in the **Outreach classes** all riders must be a USHJA member at the Outreach level or higher. Competitors may fill out an application at registration and pay the USHJA Outreach show fee and yearly membership at the competition for their points to count for that show.

Class Descriptions

Warm Up

Cost \$25 per Warm Up Class. Non-judged warm-up rounds will be available for a **\$25** fee per round in the main arena. These warm ups are open to all horses and riders provided they have a completed entry form and signed waiver for the competition. Horses or riders do not have to be entered in any specific height division to enter to ride in any warm up. Any horse or rider entered in the horse show may ride in any warm up. There will be seven (7) specific warm-up sessions based on fence height. Fences will be available at the minimum height in each warm-up. The designated warm-up round that all warm-up competitors will ride, will be the posted Course A or Course B. Riders and horses may enter the warm-up multiple times with the same rider or different riders. A rider that is entered in multiple warm-up rounds may select to remain in the arena to complete the additional warm up round. NOTE: There is a limit of two (2) rounds per horse per warm-up division. See class list for schedule of warm-up classes.

HHSA Open Performance classes are open classes and are therefore open to all riders (Non-Professionals, Professionals, Adult, Adult Amateurs, and Children/Juniors). A Performance Working Hunter is a horse of any age, which is not restricted by previous showing in any divisions. All Hunters will be judged on performance and soundness unless otherwise noted. The Horse may be shown in the under saddle by a different rider than in the over fences portion of the division. The horse's original number must be used and all points follow the horse. This rider must be entered in the horse show and all waivers and paperwork must be completed prior to the start of the class.

Fences shall simulate obstacles found in the hunting field, such as brush, stonewall, white board gate, rail, or fence, natural rail, chicken coop, or other natural obstacles. The Open Performance Hunter Division is available at six heights: 2'0", 2'3", 2'6", 2'9", 3'0", 3'3", 3'6". A Performance Hunter is a horse of any age and is not restricted by previous showing in any other division. **Fences may not exceed the maximum height.**

Need not be jogged for soundness. Cross entry between open performance divisions is permissible. HHSA show championships and year end points in these classes are accrued by the horse provided both horse, horse owner, and rider are members of HHSA.

HHSA Open Performance Hunter 2'0" – Course A: A minimum of 7 fences not to exceed 2'0" with at least one change of direction. Spreads not to exceed the height of the fence. No in and outs or oxers are permitted. Lead changes through trot not to be penalized.

HHSA Open Performance Hunter 2'0" – Course B: A minimum of 7 fences not to exceed 2'0" with at least one change of direction. Spreads not to exceed the height of the fence. No in and outs or oxers are permitted. Lead changes through trot not to be penalized.

HHSA Open Performance Hunter 2'3" – Course A: A minimum of 7 fences not to exceed 2'3" with at least one change of direction. Spreads not to exceed the height of the fence. No in and outs or oxers are permitted. Lead changes through trot not to be penalized.

HHSA Open Performance Hunter 2'3" – Course B: A minimum of 7 fences not to exceed 2'3" with at least one change of direction. Spreads not to exceed the height of the fence. No in and outs or oxers are permitted. Lead changes through trot not to be penalized.

HHSA Open Performance Hunter 2'6" – Course A: A minimum of 7 fences not to exceed 2'6" with at least one change of direction. Spreads not to exceed the height of the fence. No in and outs are permitted.

HHSA Open Performance Hunter 2'6" – Course B: A minimum of 7 fences not to exceed 2'6". Spreads not to exceed the height of the fence. No in and outs are permitted.

HHSA Open Performance Hunter 2'9" – Course A: A minimum of 7 fences not to exceed 2'9" with at least one change of direction. Spreads not to exceed the height of the fence.

HHSA Open Performance Hunter 2'9" – Course B: A minimum of 7 fences not to exceed 2'9" with at least one change of direction. Spreads not to exceed the height of the fence.

HHSA Open Performance Hunter 3'0" – Course A: A minimum of 7 fences not to exceed 3'0" with at least one change of direction. Spreads not to exceed the height of the fence.

HHSA Open Performance Hunter 3'0" – Course B: A minimum of 7 fences not to exceed 3'0" with at least one change of direction. Spreads not to exceed the height of the fence.

HHSA Open Performance Hunter 3'3" – Course A: A minimum of 7 fences not to exceed 3'3" with at least one change of direction. Spreads not to exceed the height of the fence.

HHSA Open Performance Hunter 3'3" – Course B: A minimum of 7 fences not to exceed 3'3" with at least one change of direction. Spreads not to exceed the height of the fence.

HHSA Open Performance Hunter 3'6" – Course A: A minimum of 7 fences not to exceed 3'6" with at least one change of direction. Spreads not to exceed the height of the fence.

HHSA Open Performance Hunter 3'6" – Course B: A minimum of 7 fences not to exceed 3'6" with at least one change of direction. Spreads not to exceed the height of the fence.

HHSA Open Performance Hunter 2'0" Under Saddle: To be shown at the walk, trot and canter both ways of the ring. Light contact with the horse's mouth is required. Horses should be alert, obedient, responsive, and move freely. They should not be eliminated for small errors. Horses will not be asked to hand gallop. To be eligible for this class, horses must have been shown and judged in 2'0" Performance Hunter, Course A or B. The Horse may be shown in the under saddle by a different rider than in the over fences portion of the division. The horse's original number must be used and all points follow the horse. This rider must be entered in the horse show and all waivers and paperwork must be completed. If there are ten or more entries (or per judge's discretion) the class may be split for the canter work.

HHSA Open Performance Hunter 2'3" Under Saddle: To be shown at the walk, trot and canter both ways of the ring. Light contact with the horse's mouth is required. Horses should be alert, obedient, responsive, and move freely. They should not be eliminated for small errors. Horses will not be asked to hand gallop. To be eligible for this class, horses must have been shown and judged in 2'3" Performance Hunter, Course A or B. The Horse may be shown in the under saddle by a different rider than in the over fences portion of the division. The horse's original number must be used and all points follow the horse. This rider must be entered in the horse show and all waivers and paperwork must be completed. If there are ten or more entries (or per judge's discretion) the class may be split for the canter work.

HHSA Open Performance Hunter 2'6" Under Saddle: To be shown at the walk, trot and canter both ways of the ring. Light contact with the horse's mouth is required. Horses should be alert, obedient, responsive, and move freely. They should not be eliminated for small errors. Horses may be asked to hand gallop collectively, one way of the ring, at the discretion of the Judge. No more than 8 horses will be asked to hand gallop at one time. To be eligible for this class, horses must have been shown and judged in 2'6" Performance Hunter, Course A or B. The Horse may be shown in the under saddle by a different rider than in the over fences portion of the division. The horse's original number must be used and all points follow the horse. This rider must be entered in the horse show and all waivers and paperwork must be completed. If there are ten or more entries (or per judge's discretion) the class may be split for the canter work.

HHSA Open Performance Hunter 2'9" Under Saddle: To be shown at the walk, trot and canter both ways of the ring. Light contact with the horse's mouth is required. Horses should be alert, obedient, responsive, and move freely. They should not be eliminated for small errors. Horses may be asked to hand gallop collectively, one way of the ring, at the discretion of the Judge. No more than 8 horses will be asked to hand gallop at one time. To be eligible for this class, horses must have been shown and judged in 2'9" Performance Hunter, Course A or B. The Horse may be shown in the under saddle by a different rider than in the over fences portion of the division. The horse's original number must be used and all points follow the horse. This rider must be entered in the horse show and all waivers and paperwork must be completed. If there are ten or more entries (or per judge's discretion) the class may be split for the canter work.

HHSA Open Performance Hunter 3'0" Under Saddle: To be shown at the walk, trot and canter both ways of the ring. Light contact with the horse's mouth is required. Horses should be alert, obedient, responsive, and move freely. They should not be eliminated for small errors. Horses may be asked to hand gallop collectively, one way of the ring, at the discretion of the Judge. No more than 8 horses will be asked to hand gallop at one time. To be eligible for this class, horses must have been shown and judged in 3'0" Performance Hunter, Course A or B. The Horse may be shown in the under saddle by a different rider than in the over fences portion of the division. The horse's original number must be used and all points follow the horse. This rider must be entered in the horse show and all waivers and paperwork must be completed. If there are ten or more entries (or per judge's discretion) the class may be split for the canter work.

HHSA Open Performance Hunter 3'3" Under Saddle: To be shown at the walk, trot and canter both ways of the ring. Light contact with the horse's mouth is required. Horses should be alert, obedient, responsive, and move freely. They should not be eliminated for small errors. Horses may be asked to hand gallop collectively, one way of the ring, at the discretion of the Judge. No more than 8 horses will be asked to hand gallop at one time. To be eligible for this class, horses must have been shown and judged in 3'3" Performance Hunter, Course A or B. The Horse may be shown in the under saddle by a different rider than in the over fences portion of the division. The horse's original number must be used and all points follow the horse. This rider must be entered in the horse show and all waivers and paperwork must be completed. If there are ten or more entries (or per judge's discretion) the class may be split for the canter work.

HHS A Open Performance Hunter 3'6" Under Saddle: To be shown at the walk, trot and canter both ways of the ring. Light contact with the horse's mouth is required. Horses should be alert, obedient, responsive, and move freely. They should not be eliminated for small errors. Horses may be asked to hand gallop collectively, one way of the ring, at the discretion of the Judge. No more than 8 horses will be asked to hand gallop at one time. To be eligible for this class, horses must have been shown and judged in 3'6" Performance Hunter, Course A or B. The Horse may be shown in the under saddle by a different rider than in the over fences portion of the division. The horse's original number must be used and all points follow the horse. This rider must be entered in the horse show and all waivers and paperwork must be completed. If there are ten or more entries (or per judge's discretion) the class may be split for the canter work.

Adult Amateur Working Hunter Division
COST \$30 per Class

All Adult Amateurs must have current USEF Amateur Certification to enter these classes.

To be ridden by adults who meet USEF eligibility requirements for Amateur status and have current USEF amateur certification. To be judged on performance and soundness over a minimum of 7 fences with at least one change of direction. Fence heights not to exceed the stated height, spreads not to exceed the height of the fence. No fences may exceed the maximum height. Ponies may be ridden by an adult, suitability to count. Entries need not be jogged for soundness. This rider must be entered in the horse show and all waivers and paperwork must be completed before the class commences. An adult amateur may ride more than one horse in an Adult Amateur division. A horse cannot be ridden by multiple riders.

HHS A Introductory Adult Amateur Hunter 2'0" – Course A: A minimum of 7 fences not to exceed 2'0" in height with at least one change of direction. No in and outs or oxers are permitted at this height. Spreads not to exceed the height of the fence. **Riders may not cross enter into other Adult Amateur Working Hunter Divisions at the same show.** Lead changes through the trot will not be penalized.

HHS A Introductory Adult Amateur Hunter 2'0" – Course B: A minimum of 7 fences not to exceed 2'0" in height with at least one change of direction. No in and outs or oxers are permitted at this height. Spreads not to exceed the height of the fence. **Riders may not cross enter into other Adult Amateur Working Hunter Divisions at the same show** Lead changes through the trot will not be penalized.

HHS A Low Adult Amateur Hunter 2'3" – Course A: A minimum of 7 fences not to exceed 2'3" in height with at least one change of direction. No in and outs or oxers are permitted at this height. Spreads not to exceed the height of the fence. **Riders may not cross enter into other Adult Amateur Working Hunter Divisions at the same show** Lead changes through the trot may not be penalized.

HHS A Low Adult Amateur Hunter 2'3" – Course B: A minimum of 7 fences not to exceed 2'3" in height with at least one change of direction. No in and outs or oxers are permitted at this height. Spreads not to exceed the height of the fence. **Riders may not cross enter into other Adult Amateur Working Hunter Divisions at the same show** Lead changes through the trot may not be penalized.

HHS A Medium Adult Amateur Hunter 2'6" – Course A: A minimum of 7 fences not to exceed 2'6" in height with at least one change of direction. No in and outs are permitted at this height. Spreads not to exceed the height of the fence. **Riders may not cross enter into other Adult Amateur Working Hunter Divisions at the same show**

HHS A Medium Adult Amateur Hunter 2'6" – Course B: A minimum of 7 fences not to exceed 2'6" in height with at least one change of direction. No in and outs are permitted at this height. Spreads not to exceed the height of the fence. **Riders may not cross enter into other Adult Amateur Working Hunter Divisions at the same show**

HHS A High Adult Amateur Hunter 2'9" – Course A: A minimum of 7 fences not to exceed 2'9" in height with at least one change of direction. No in and outs are permitted at this height. Spreads not to exceed the height of the fence. **Riders may not cross enter into other Adult Amateur Working Hunter Division at the same show**

HHS A High Adult Amateur Hunter 2'9" – Course B: A minimum of 7 fences not to exceed 2'9" in height with at least one change of direction. No in and outs are permitted at this height. Spreads not to exceed the height of the fence. **Riders may not cross enter into other Adult Amateur Working Hunter Divisions at the same show**

HHS A Introductory Adult Amateur Hunter Under Saddle 2'0": Not to jump. To be shown at the walk, trot and canter both ways of the ring. Light contact with the horse's mouth is required. Horses should be alert, obedient, responsive, and move freely. They should not be eliminated for small errors. Horses may not be asked to hand gallop. If there are ten or more entries (or per judge's discretion) the class may be split for the canter work. To be eligible for this class, horses must have been shown and judged in 2'0" Introductory Adult Amateur Hunter, Course A or B.

HHS A Low Adult Amateur Hunter Under Saddle 2'3": Not to jump. To be shown at the walk, trot and canter both ways of the ring. Light contact with the horse's mouth is required. Horses should be alert, obedient, responsive, and move freely. They should not be eliminated for small errors. Horses may not be asked to hand gallop. If there are ten or more entries (or per judge's discretion) the class may be split for the canter work. To be eligible for this class, horses must have been shown and judged in 2'3" Low Adult Amateur Hunter, Course A or B.

HHS A Medium Adult Amateur Hunter Under Saddle 2'6": Not to jump. To be shown at the walk, trot and canter both ways of the ring. Light contact with the horse's mouth is required. Horses should be alert, obedient, responsive, and move freely. They should not be eliminated for small errors. Horses may be asked to hand gallop collectively, one way of the ring, at the discretion of the Judge. No more than 8 horses will be asked to hand gallop at one time. If there are ten or more entries (or per judge's discretion) the class may be split for the canter work. To be eligible for this class, horses must have been shown and judged in 2'6" Medium Adult Amateur Hunter, Course A or B.

HHSA High Adult Amateur Hunter Under Saddle 2'9": Not to jump. To be shown at the walk, trot and canter both ways of the ring. Light contact with the horse's mouth is required. Horses should be alert, obedient, responsive, and move freely. They should not be eliminated for small errors. Horses may be asked to hand gallop collectively, one way of the ring, at the discretion of the Judge. No more than 8 horses will be asked to hand gallop at one time. If there are ten or more entries (or per judge's discretion) the class may be split for the canter work. To be eligible for this class, horses must have been shown and judged in 2'9" High Adult Amateur Hunter, Course A or B.

Children's Working Hunter Division
Cost \$30/Class

Open to horses and ponies to be ridden by a Junior Exhibitor (17 years old and under). To be judged on performance and soundness over a minimum of 7 fences with at least one change of direction. In all classes, manners will be emphasized and extreme speed will be penalized. Fences may not exceed the maximum height stated. Spreads may not exceed the height of the fence. Entries need not be jogged for soundness. This rider must be entered in the horse show and all waivers and paperwork must be completed before the class commences. A child may ride more than one horse in a children's division. A horse cannot be ridden by multiple riders.

HHSA Introductory Children's Hunter 2'0" – Course A: A minimum of 7 fences not to exceed 2'0" in height with at least one change of direction. No in and outs or oxers are permitted at this height. Spreads not to exceed the height of the fence. **Riders may not cross enter in other Children's Working Hunter Divisions at the same show.** Lead changes through the trot will not be penalized.

HHSA Introductory Children's Hunter 2'0" – Course B: A minimum of 7 fences not to exceed 2'0" in height with at least one change of direction. No in and outs or oxers are permitted at this height. Spreads not to exceed the height of the fence. **Riders may not cross enter in other Children's Working Hunter Divisions at the same show.** Lead changes through the trot will not be penalized.

HHSA Low Children's Hunter 2'3" – Course A: A minimum of 7 fences not to exceed 2'3" in height with at least one change of direction. No in and outs or oxers are permitted at this height. Spreads not to exceed the height of the fence. **Riders may not cross enter in other Children's Working Hunter Divisions at the same show.** Lead changes through the trot may not be penalized.

HHSA Low Children's Hunter 2'3" – Course B: A minimum of 7 fences not to exceed 2'3" in height with at least one change of direction. No in and outs or oxers are permitted at this height. Spreads not to exceed the height of the fence. **Riders may not cross enter in other Children's Working Hunter Divisions at the same show.** Lead changes through the trot may not be penalized.

HHSA Medium Children's Hunter 2'6" – Course A: A minimum of 7 fences not to exceed 2'6" in height with at least one change of direction. No in and outs are permitted at this height. Fence height not to exceed 2'6". Spreads not to exceed the height of the fence. **Riders may not cross enter in other Children's Working Hunter Divisions at the same show**

HHSA Medium Children's Hunter 2'6" – Course B: A minimum of 7 fences not to exceed 2'6" in height with at least one change of direction. No in and outs are permitted at this height. Fence height not to exceed 2'6". Spreads not to exceed the height of the fence. **Riders may not cross enter in other Children's Working Hunter Divisions at the same show**

HHSA High Children's Hunter 2'9" – Course A: A minimum of 7 fences not to exceed 2'9" in height with at least one change of direction. No in and outs are permitted at this height. Fence height not to exceed 2'9". Spreads not to exceed the height of the fence. **Riders may not cross enter in other Children's Working Hunter Divisions at the same show**

HHSA High Children's Hunter 2'9" – Course B: A minimum of 7 fences not to exceed 2'9" in height with at least one change of direction. No in and outs are permitted at this height. Fence height not to exceed 2'9". Spreads not to exceed the height of the fence. **Riders may not cross enter in other Children's Working Hunter Divisions at the same show**

HHSA Introductory Children's Hunter Under Saddle 2'0": Not to jump. To be shown at the walk, trot and canter both ways of the ring. Light contact with the horse's mouth is required. Horses should be alert, obedient, responsive, and move freely. They should not be eliminated for small errors. Horses may not be asked to hand gallop. If there are ten or more entries (or per judge's discretion) the class may be split for the canter work. To be eligible for this class, horses must have been shown and judged in 2'0" Introductory Children's Hunter, Course A or B.

HHSA Low Children's Hunter Under Saddle 2'3": Not to jump. To be shown at the walk, trot and canter both ways of the ring. Light contact with the horse's mouth is required. Horses should be alert, obedient, responsive, and move freely. They should not be eliminated for small errors. Horses may not be asked to hand gallop. If there are ten or more entries (or per judge's discretion) the class may be split for the canter work. To be eligible for this class, horses must have been shown and judged in 2'3" Low Children's Hunter, Course A or B.

HHSA Medium Children's Hunter Under Saddle 2'6": Not to jump. To be shown at the walk, trot and canter both ways of the ring. Light contact with the horse's mouth is required. Horses should be alert, obedient, responsive, and move freely. They should not be eliminated for small errors. Horses may be asked to hand gallop collectively, one way of the ring, at the discretion of the Judge. No more than 8 horses will be asked to hand gallop at one time. To be eligible for this class, horses must have been shown and judged in 2'6" Medium Children's Hunter, Course A or B. If there are ten or more entries (or per judge's discretion) the class may be split for the canter work.

HHSA High Children's Hunter Under Saddle 2'9": Not to jump. To be shown at the walk, trot and canter both ways of the ring. Light contact with the horse's mouth is required. Horses should be alert, obedient, responsive, and move freely. They

should not be eliminated for small errors. Horses may be asked to hand gallop collectively, one way of the ring, at the discretion of the Judge. No more than 8 horses will be asked to hand gallop at one time. To be eligible for this class, horses must have been shown and judged in 2'9" Medium Children's Hunter, Course A or B. If there are ten or more entries (or per judge's discretion) the class may be split for the canter work.

USHJA Outreach Hunter Classes

To be held concurrently with HHSA Introductory Children's/Adult Amateur Working Hunter Classes, HHSA Low Children's/Adult Amateur Working Hunter Classes, HHSA Medium Children's/Adult Amateur Working Hunter Classes and HHSA High Children's/Adult Amateur Working Hunter Classes . Riders must be USHJA members for their points to count. Unlike HHSA Hunter classes where the points follow the horse, USHJA Outreach Classes award points to the rider. USHJA Outreach Classes combine both Children and Adult Amateurs for their year-end award. Throughout the year riders may check their point accrual online on the USHJA Outreach website.

Medals Division

Medal/Equitation over Fences Classes:

HHSA Medal classes may be offered at five heights: **2'3", 2'6", 2'9" 3'0" and 3'3"**

NOTE:

Riders to show in the same Medal height class of the Working Hunter Division that they are competing in. If a rider is only competing in the Medal class and NOT the Working Hunter Classes then they may choose any height. However, there is no cross entry between Medal classes at the same show; however, riders may change from one section to another in subsequent shows.

HHSA Medal Classes are open to Junior's (17 years old and under) and Adult Amateurs with current USEF Amateur Certification. Medal classes test a rider's ability to navigate a course consisting of a minimum of 6 obstacles and one or two changes of direction. Additional USEF tests may be required and may be incorporated into the over fences round. Competitors who are HHSA members can accrue points toward HHSA Medal Year-end Awards in 2'3", 2'6", 2'9" 3'0" and 3'3" classes

HHSA Children's/Adult Amateur Medal 2'3": Open to juniors (17 and under) and Adult Amateurs (with current USEF Amateur certification).. Fences may not exceed maximum height. No combinations or oxers are allowed at this height. Lead changes through the trot will not be penalized.

This class will be held concurrently with the Amy Rich Memorial Trophy 2'3" for riders 13 and under. If a rider is a member of HHSA their points will be accrued for HHSA year-end awards.

Amy Rich Memorial Trophy 2'3": Only riders who are 13 years old and under AND who are also members of HHSA will accrue points toward the end-of-year Amy Rich Award in the HHSA Medal Class 2'3". This year-end memorial was established to give incentive to the very young and to honor the woman who devoted her life to the encouragement and instruction of young people in the care and riding of horses. The Amy Rich Award is only open to riders 13 years old and under. Riders lose eligibility for consideration if they compete over a course in any competition where the height exceeds 2'3". This class will be held concurrently with the HHSA Medal Class 2'3". Riders (13 years old and under) who are members of HHSA may also accrue year-end HHSA Low Medal points in this class. Juniors (17 and under) not qualified for Amy Rich may accrue year-end HHSA Medal 2'3" points in this class. Adult Amateurs who are HHSA members may accrue year-end HHSA Medal 2'3" points in this class.

HHSA Children's/Adult Amateur Medal 2'6": Open to Juniors (17 and under) and Adult Amateurs (who have current USEF Amateur Certification). This Medal class tests a rider's ability to navigate a course consisting of a minimum of 6 obstacles and one or two changes of direction. Additional USEF tests may be required and may be incorporated into the over fences round. No in and out combinations are allowed at this height. Fences may not exceed maximum height. Spreads cannot exceed the fence height. Juniors and Adult Amateurs may accrue HHSA Medal 2'6" points in this class if they are members of HHSA.

HHSA Children's/Adult Amateur Medal 2'9": Open to Juniors (17 and under) and Adult Amateurs (who have current USEF Amateur Certification). This Medal class tests a rider's ability to navigate a course consisting of a minimum of 6 obstacles and one or two changes of direction. Additional USEF tests may be required and may be incorporated into the over fences round. No in and out combinations are allowed at this height. Fences may not exceed maximum height. Spreads cannot exceed the fence height. Juniors and Adult Amateurs may accrue HHSA Medal 2'9" points in this class if they are members of HHSA.

HHSA Children's/Adult Amateur Medal 3'0": Open to Juniors (17 and under) and Adult Amateurs (with current USEF Amateur certification). Combinations and further testing are encouraged but not required. Juniors and Adult Amateurs who are members of HHSA may accrue year-end HHSA Medal 3'0" points in this class.

HHSA Children's/Adult Amateur Adult Amateur Medal Class 3'3": Open to Juniors (17 and under) and Adult Amateurs (with current USEF Amateur certification). This Medal class tests a rider's ability to navigate a course consisting of a minimum of 6 obstacles and one or two changes of direction. Additional USEF tests may be required and may be incorporated into the over fences round. Combinations and further testing are encouraged but not required. Juniors and Adult Amateurs who are members of HHSA may accrue year-end HHSA Medal 3'3" points in this class.

NOTE: There is no cross entry between medal classes at the same show; however, riders may change from one section to another in subsequent shows.

Hunter Seat Equitation Not to Jump

HHSA Hunter Seat Equitation Not to Jump (13 years old and under): To be judged at the walk, trot and canter both ways of the ring. Additional USEF tests may be requested at the judge's discretion. If there are ten or more entries, or at the judge's discretion, the class may be split for canter work.

HHSA Hunter Seat Equitation Not to Jump (14 to 17 years old): To be judged at the walk, trot and canter both ways of the ring. Additional USEF tests may be requested at the judge's discretion. If there are ten or more entries, or at the judge's discretion, the class may be split for canter work.

HHSA Adult Amateur Hunter Seat Equitation Not to Jump: Open to Adult Amateurs with current USEF Amateur Certification. To be judged at the walk, trot and canter both ways of the ring. Additional USEF tests may be requested at the judge's discretion. If there are ten or more entries, or at the judge's discretion, the class may be split for canter work.

Note: No Cross-entry between Equitation age divisions is permitted. Age is of January 1 of that show year.

Long Stirrups / Short Stirrups Division **Short Stirrup Opportunity Division**

Open to riders of all ages. **These classes are designed for the less experienced rider** who wishes to gain show experience and who has shown for no more than two (2) show seasons (partial seasons to count). Riders in this division may not cross enter into any other division or class in the horse show. Riders may not cross enter ground pole and cross rail classes.

NOTE: WU-8 is an open warm up. Any horse-rider combination is allowed to enter multiple rounds with multiple riders if desired.

HHSA Long Stirrups/Short Stirrups Hunter Seat Equitation (walk, trot) not to jump, not to canter: To be judged at a walk and trot both ways of the ring.

HHSA Long Stirrups/Short Stirrups Hunter Seat Equitation (walk, trot, canter) not to jump: To be judged at a walk, trot and canter both ways of the ring. Note: Competitors will canter individually

HHSA Long Stirrups/Short Stirrups Hunter Seat Equitation Over Ground Poles

To be judged over a maximum of 5 ground poles. Ground poles may be taken at the walk, trot or canter. Lead changes through the trot will not be penalized.

HHSA Long Stirrups/Short Stirrups Hunter Seat Equitation Over Cross Rails: To be judged over a maximum of 5 cross rails not to exceed 18". Cross rails may be taken at the trot or canter. Lead changes through the trot will not be penalized. Except for refusals, jumping faults of the horse are not considered unless they are the fault of the rider.

Pleasure Division

HHSA Open English Pleasure Horse \$100 Stake: Open to horses and ponies. To be judged at the walk, trot and canter both ways of the ring. The English Pleasure Horse may be a stallion, mare, or gelding of any type or breed. It is imperative that the horse gives the distinct appearance of being a pleasure to ride and display a pleasurable attitude. To this end, all gaits must be performed with willingness and obvious ease, cadence, balance and smoothness. There is an emphasis on manners and ability to afford a pleasurable ride. At least three riders must compete for the class to be held.

Special Classes – WILL NOT BE HELD

HHSA Low Derby 2'3" – 2'6" \$100 Stake: Open to all riders. This Derby is held over a single round course of 8 fences at 2'3" in height, with three (3) option fences set at 2'6". Obstacles are reminiscent of the hunt field and should offer a variety of appearances, such as natural post and rail, stone wall, white board fence or gate, coop, aiken, hedge, oxer, brush, logs and natural foliage. The course will consist of Hunter Classic and Hunter Handy style lines, turns and jumps and include

hand galloping and/or trotting a fence. The Judge will use the open numerical scoring system. After the Judge's score is given, one point will be added for each high option fence jumped successfully (no knockdowns or refusals) for a maximum of three additional points added to the Judge's score. At least three riders must compete for the class to be held. Ribbons are awarded to eight places.

HHSA Medium Derby 2'6" – 2'9" \$100 Stake/USHJA Outreach Hunter Derby: Open to all riders. This Derby is held over a single round course of 10 fences at 2'6" in height, with three (3) option fences set at 2'9". Obstacles are reminiscent of the hunt field and should offer a variety of appearances, such as natural post and rail, stone wall, white board fence or gate, coop, aiken, hedge, oxer, brush, logs and natural foliage. The course will consist of Hunter Classic and Hunter Handy style lines, turns and jumps and include hand galloping and/or trotting a fence. The Judge will use the open numerical scoring system. After the Judge's score is given, one point will be added for each high option fence jumped successfully (no knockdowns or refusals) for a maximum of three additional points added to the Judge's score. At least three riders must compete for the class to be held. Ribbons are awarded to eight places.

HHSA High Derby 2'9" – 3'0" \$100 Stake/USHJA Outreach Hunter Derby: Open to all riders. This is a two-round format utilizing the open numerical system to score competitors in the Classic Hunter Round (first round) on performance, hunter pace, jumping style, quality and substance, and movement. In addition, the base score in the Handy Hunter round (second round) reflects brilliance of pace and handiness. In each round, after the Judge's base score is given, one point will be added for each high option fence jumped up to a maximum of two. The point must be added even if there is a refusal, rail down, or a loss of good jumping style at that fence, providing that the horse and rider combination does jump the higher height fence option. Obstacles are reminiscent of the hunt field and must offer a variety of appearances, such as natural post and rail, stone wall, white board fence or gate, coop, aiken, hedge, oxer, brush, logs and natural foliage. The Handy Hunter round should simulate riding over hunt country and incorporate options such as tight turns, clever options for jump approaches, hand galloping and trotting a fence. Fences for the HHSA Derby are set at 2'9" with two high option fences set at 3'0". Horse and rider combinations scoring 60 percent or higher (or at the Judge's discretion) after the first round are eligible to return for the second round. The pair with the highest two-round score is declared the class winner. Ribbons are awarded to eight places. At least three riders must compete for the class to be held.
